Xiong United Board Meeting Minutes

July 27, 2002

- Reports
 - We held a special board meeting on August 8, 2022 to address President Ntxoov Pov Xyooj's request to help mediate a dispute between the Xiong leadership in WI and him, but the Xiong Council of WI does not want XU to be involved; therefore, XU will not conduct any further activities to deal with the issue.
 - Hmong American National Chairman Association (HANCA) was created after the death of General Vang Pao. It contains a representative from each clan; typically, the representative is the national leader of each clan.
